This Public Law 95-210 Rural Health Clinic provides comprehensive healthcare for individuals who lack access to medical services due to economic or social barriers. Physicians, physician assistants, nurse practitioners, and medical support staff offer a full range of quality services. The Clinic accepts most insurance including Medi-Cal, Medicare, CMSP, CHDP, Healthy Families, self-pay and private medical insurance like Anthem Blue Cross or Blue Shield.
