	Go-bags that would supply 4 people for 3 days were distributed through a partnership with DSS for their Access and Functional Needs clients and we also provided to clients on the California Children's Services Medical Therapy Program. Connected Living is getting 1,000 go-bags and maybe funding for additional bags for Tehama County. A local bank might also be providing more funding for more go-bags.

	Val has been actively involved in the homelessness issue and how the funding should be used. Val has been convening the partners to direct funding on outreach and mobile crisis response for behavioral health to do more assessments. What should that look like and how to best accomplish the goals to meet community needs.	
	Planning for Public Health Week. This year is the 25 th anniversary of Public Health Week. With St. Elizabeth Community Hospital's assistance we are hosting a Provider Conference to discuss STDs, immunizations, tuberculosis and emergency preparedness. There is a guest speaker coming from CDPH to discuss STDs as well as one to discuss Tuberculosis. We are in the process of working with Dignity Health to get CMEs for providers. Tehama County Health Officer, Dr. Richard Wickenheiser is facilitating the discussions. We are one of few counties who treat latent TB and there will be a good discussion around tuberculosis. 	Working on moving towards an electronic health record system and apply to be a Medi-cal provider. Hoping to provide electronic/remote DOT similar to telehealth. CAIR; currently there is no mandate for pharmacies to enter vaccinations into the database. If you do get a vaccine done at the pharmacy and they don't enter it you can bring the paperwork to your doctor or Public Health and it can get entered. We want to increase outreach to pharmacies. Jean suggested to invite pharmacists to the conference. Vaping forum 2/19 11:30-1 for parents. Tobacco program is only focused on Tobacco, not on marijuana.
