Provide advocacy with state and federal legislative bodies on health and budgetary issues affecting Tehama County

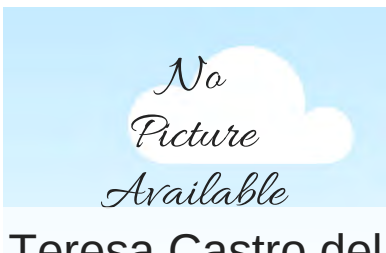

The Dental Committee consists of dental providers and various organizations working to increase the oral health in our community.

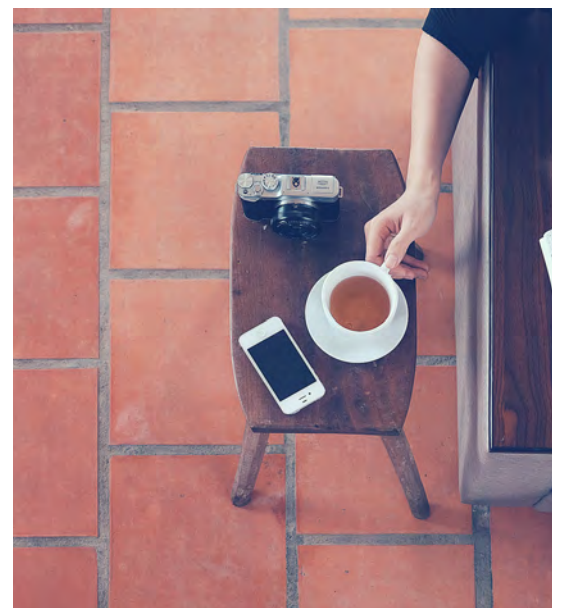
## SSAFE Committee

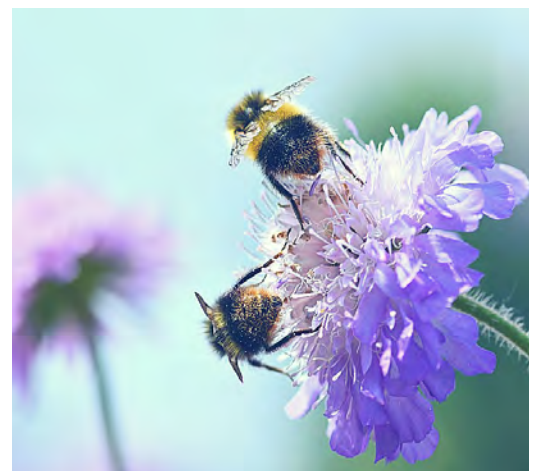

# DENTAL COMMITTEE

*Improving the Oral Health of our Community*

## Accomplishments

*We are proud of these accomplishments over the past year*

- In its second year, the five-year California Department of Public Health, Oral Health Program, funded by Proposition 56, provides the framework and personnel to educate, develop programs, and create policies to improve the awareness of the importance of oral health to total health. The community oral survey, completed by 966 individuals, helped identify the needs of the community. The completed Community Oral Health Improvement Plan and Action Plan were completed and submitted to the California State Office of Oral Health.
- Collaborated with First 5 Tehama and the Nutrition Education Obesity Prevention Program to support healthy beverage messaging and policies to reduce consumption of sugary beverages.
- Maintained a Dentist Provider Resource list. A list of Local Dentists Providing Conscious Sedation has been maintained and shared with school nurses and other agencies.
- Established a connection with School Nurses to screen children at Kindergarten Registration and at the schools. Assembly Bill 1433 requires children receive an assessment of oral health as part of school readiness activities for kindergarten entry.
- Rolling Hills Dental Clinic received grant funding for The Virtual Dentistry Program with help from Dr. Lucio and Delta Dental. The program was launched 12/06/18 and services were provided to NCCDI children at their program sites. Rolling Hills Dental Clinic purchased a Mobile Dental Clinic and will refurbish.
- Mary Jacobson has been providing fluoride varnish training to local medical providers.

## **Accomplishments continued...**

*We are proud of these accomplishments over the past year*

- Continued to collaborate with partners including: Rolling Hills Dental Clinic, Greenville Rancheria Dental Clinic, Northern Valley Indian Health Dental Clinic, Corning Health Center, the Shasta College Dental Hygiene Program, the Red Bluff High School ROP, Shasta Dental Hygiene Society, Northern California Dental Society, Walter Lucio DDS, MPH, the Outreach Dental Consultant, State Government Programs, Medi-Cal Dental and Rebecca Hoffar,
- Disseminated oral health education and prevention information to community residents at six county locations and outreach events including:
  - Cuts for Kids, Sunday, August 12, 2018
  - LIFT Tehama and Recycle the Warmth, Friday, November 9, 2018. Screened 120 adults, provided health education, toothbrushes and referrals to local clinics as needed.
  - Jackson Heights Kindergarten Registration March 7, 2018
  - Gerber School Kindergarten Registration April 12, 2018
  - Children's Fair, Saturday, April 27, 2019
  - Cinco de Mayo, May 4, 2019

## Goals

*We look forward to reaching these goals*

- Maintain the Dental Resource List
- Train Medical Providers to add fluoride varnish to well-child exams
- Complete the Oral Health Community Health Improvement Plan goals and objectives for the year.
- Launch the Brush, Book, Bed campaign to encourage parents to create a nightly routine for children that includes brushing their teeth.
- Reapply for designation as a Dental Health Professional Shortage Area. This allows for loan repayment programs and higher reimbursement rates for providers.
- Collaborate with local dental providers; Rolling Hills Dental Clinic, Greenville Rancheria Dental Clinic, Northern Valley Indian Health Dental Clinic, Corning Health Center, the Shasta College Dental Hygiene Program, the Red Bluff High School ROP, along with the Shasta Dental Hygiene Society and the Northern California Dental Society.
- Identify the gap in access to hospital dentistry services in the county for young children. Currently, no hospital dentistry services are provided in Tehama County and families must travel long distances outside the county to Stockton, Salida and Windsor to access treatment. The need for local hospital dentistry services remains high.
- Keep the Tehama County Board of Supervisors apprised of the status of oral health care accessibility for low-income individuals in our county.

# SSAFE COMMITTEE

*Preventing Teen Pregnancy through Education*

## Accomplishments

*We are proud of these accomplishments over the past year*

- Took the TCHSA Mobile Clinic to Salisbury High School to provide HPV Vaccinations to students.
- Program Protect was taught in some Middle Schools.
- Completed and Distributed a “Teen Sexual and Reproductive Health Care Rights” brochure that meets the California Healthy Youth Act requirements.
- TCHSA Medical Clinic has successfully accommodated needs of youth to schedule them for reproductive health appointments and family planning education.
- TCHSA Medical Clinic practitioners went to Salisbury High School and provided students sex education.

## Goals

*We look forward to reaching these goals*

- Facilitate coordination between Juvenile Hall, Public Health and a School Nurse to provide sex education to Juvenile Hall youth.
- Facilitate coordination between Juvenile Hall, TCHSA Medical Clinic and Public Health to provide family planning options, immunizations, and oral health care/education as part of re-entry process.
- Use cancer screening kits from Public Health to do community education on breast cancer and testicular cancer.
- Launch a community outreach campaign during Teen Health Week which is April 6-12, 2020.
- Raise awareness of human trafficking issues and educational/training opportunities for the community.
