Public Health	shared and posted. COVID-19 cases are declining, as are testing rates. Our state staff are still continuing to do the case investigations and now are reaching out to the individuals who have tested positive and checking in on them to see if they are experiencing any long-term side effects. National Guard continues to assist us in vaccine clinic operations at the Red Bluff Community Center. Scheduling is now done through the state's system; www.myturn.ca.gov . This system will handle scheduling, data entry and upload to the CAIR system. Our vaccine allocation continues to fluctuate in quantity and brands. We have distributed 8,452 vaccines. There are 3,402 people who have completed their two-dose series. We just received our first allocation of Johnson & Johnson vaccine and are working on a distribution plan for that allocation. Youth sports are starting up locally and we provided testing clinics at all three high schools this week; Red Bluff, Corning and Los Molinos. Participants in these programs are to be tested weekly and they are allowed to use the antigen Binax test kits, we have available for schools to have and use. Our preference is to get schools using the PCR tests that have higher efficacy rates, are approved for asymptomatic use, and have results within 24-48 hrs.
Dept. of Social Services	The 15% increase to CalFresh has been administered to all clients. Medi-Cal continues to not discontinue or deny services.
Dignity Health Connected Living	Senior volunteers are starting to get back to work and there will be a drive-thru recognition ceremony for them in May.
Dignity Health St. Elizabeth Community Hospital	The hospital census is down to normal levels. There are 6 patients in ICU and 26 in med surge.
Empower Tehama	4/28/21 is Denim Day so please plan to promote to staff. If you have a group wearing denim and you would like Empower Tehama to come take your picture that they can share on their social media platforms give them a call. They plan to have a booth at the rodeo for the first time this year. They are looking for office space in Corning to expand services 1-2 days per week to the south county areas, if you have any ideas for space let them know.

The Read Across Tehama program and First 5 Book Club partnered with Oral Health Program to provide oral health books, toothbrush kits, and activity packets to 150 children. School Superintendent and local dental providers read oral health stories and videos are available online. TV ads on Channel 12 are promoting the Brush, Book, Bed campaign.	
Healthy Youth Tehama	Discussions are happening about how to make the teen health fair a drive-thru type of event due to COVID restrictions. The committee will be reviewing the MCAH program work plan to align goals. There seems to be a rise in teen pregnancies, will analyze local data at next meeting.
